



### Main objective

The objective for the Cornerstone Progressive Growth MAP 3 portfolio is to offer potential for returns above inflation where the investor is prepared to invest in a broadly spread portfolio with a moderate allocation of equities as well as diversification to other investments such as government and corporate debt, property and alternatives.

### Risk profile

Cornerstone Progressive Growth MAP 3 targets moderate risk and is designed for investors who would be able to tolerate a loss of 15% in one year (but understand and accept that this could be more in extreme circumstances). Benchmark is CPI +3% and target volatility 7-11.

### Investment policy

The Cornerstone Progressive Growth MAPs comprise of six portfolio options driven by the Aubrey asset allocation process and designed to meet with a range of objectives and risk. Portfolios are monitored on an ongoing basis with asset allocation formally reviewed and where appropriate rebalanced on a quarterly basis. The portfolios may hold but are not limited to, listed securities and collective investment schemes including ETFs and alternative assets and strategies.


#### Investment approach

Aubrey Capital Management is a specialist investment manager founded in 2006. Aubrey believes in achieving long-term positive returns after inflation through investing in diversified multi-asset portfolios designed to produce attractive risk-adjusted returns. When constructing each portfolio Aubrey seeks to understand the potential returns and risk from individual investments and each portfolio as a whole, using different assets to spread and diversify risk. Aubrey analyse long-term returns, risk and correlation between assets in order to maximise risk adjusted returns within the risk parameters set by the asset allocation.

#### Risk Factors

Although this strategy has been designed to provide a relatively lower level of investment risk, the value of your investment will fluctuate and you may get back less than you invest. Aubrey split different investments into the broad asset classes noted above. There are risks associated with each of these asset classes. Aubrey targets an overall level of risk from each strategy within the constraints of the asset allocation and overall target risk level.
